Sir,

This has reference to NBA's letter of even number dated 28-03-2018 under which Post Graduate Diploma in Management (Hospital & Health) program offered by your Institution was granted provisional accreditation for 3 years from Academic year 2018-19 to 2020-21 i.e up-to 30-06-2021 by National Board of Accreditation.

2. The National Board of Accreditation (NBA) has decided that in all cases of Management programs which were accredited for a period of 3 years upto 30-06-2021 in which the Institutions concerned have not been able to apply afresh for accreditation of the programs or if applied, the accreditation process could not be completed due to the current situation arising out of the pandemic caused by the Corona virus, the programs would be considered for accreditation of one year after expiry of the validity of accreditation on 30-06-2021 on the basis of the programs meeting the pre-qualifiers. The data submitted by **Institute of Health Management Research, 319 Hulimangala, Near Thimma Reddy Layout, Hulimangala post, Electronic City, Phase-1, Bangalore-560105, Karnataka** in the Pre-qualifiers has been examined and verified in NBA. Based on the same, the Competent Authority in NBA has approved the following accreditation status to the programs as given in the Table below:
