

# 2.2 Aims and Objectives

- i. Industry representative


#### 2.6 Membership Criteria and Tenure

The quorum for the meeting shall be two- thirds of the total number of members. # Role of Chairperson


- The Director of the Institute serves as the Chairperson of the IQAC, providing overall leadership and guidance for quality assurance activities.

### Roles and Responsibilities of the Coordinator
