On the rolls of the establishment and/or Engaged through the Contractor (s) or as enumerated in clause (I) of section 2 of the Act.

#### 2. OBJECTIVE

This Policy has been formulated keeping in view the provisions under the Act and rules there under. The said Policy is to define the guidelines and the process to be followed in order to provide protection against sexual harassment of women at workplace and for the prevention and redressal of complaints of sexual harassment in addition to the matters connected therewith or incidental thereto. - RE- Respondent Employee: Refers to any employee against whom the complaint for sexual iv. harassment has been lodged.
- **WORKPLACE-** as per clause O of the Act which includes all offices, branches and state/project V. offices located anywhere in India. It also includes any place visited by the employees arising out of or during employment including transportation provided by the Management of the establishment for undertaking the journey.
